b.	Vice Chair	<p>Cindy S. reported a SGVIE member bringing two Zoom admin host issues to her attention: "whiteboard" and "renaming." The member requested the whiteboard and renaming functions be removed at the Admin account level by the Zoom account administrator for better security measures. Both functions have been used by Zoom disruptors. (For example, drawing inappropriate images on the whiteboard or renaming their image to the name of a legitimate OA member or host). Karen D. stated that maybe we should not turn it off on the account level for all meetings as the meeting host has the ability to disable these functions through the security functions. The renaming function can be useful to hosts to assist members calling in by phone or those that are listening, only. Cindy S. contacted San Diego IG, who provides Zoom training for Zoom/Admin Managers and IGs. San Diego IG recommends disabling the whiteboard at the account (Admin) level for security reasons. It was decided to table the issues to allow SGVIE Zoom/Admin Administrator, Jill A., time to conduct a more thorough research, provide recommendations and, if not resolved before the next board meeting, continue on the November Agenda under "Unfinished Business."</p>
c.	Secretary - Absent. Shelby M. volunteered to acting secretary.	<p>Absent. Cindy S. noted that LaVonne was working on a calendar timeline that we will distribute to everyone. Cindy wants to see the draft timeline for the December board meeting or sooner so that people may weigh in on when things are due. She hopes to have something available before the December Board meeting.</p>

Our contributions (\$1,256.30) exceeded our expenses (\$1,244.49) this month and we are on track to end 2023 in the black.</p> <p>Karen D. sent board members a very rough draft of a SGVIE budget for 2024 based on the group's previous expenses and revenues. Members were asked to provide input by November 10th, so a budget can be at presented at the December Board meeting.</p> <p>The subject of allocating all on-line contributions to a single source was discussed. Brief discussion followed with an overwhelming support of keeping the current practice of designating the contributions to the individual meetings as requested by the member making the contribution.</p>
