SGVIE Treasurer received notice of DonorBox platform fee increase from 1.5% to 1.75% effective August 1, 2023. Only alternative to this increase would be to upgrade to a premium DonorBox plan. However the monthly fee of \$139 far exceeds our current fees so no change is recommended. July Financial Report: Monthly Report was shared. Expenses (\$1631.99) exceeded income (\$1285.81) this period by \$346.18. Annual liability insurance (\$315) was paid this month. YTD we are \$706.97 positive. No donations to R2 or WSO will be made by the intergroup this month. List of donations by meeting was shared. Attendees were reminded that groups that meet at other locations (not @ SGVIE meeting room), are required to pay their location's rent and may provide literature. Of donations received in July, 55% were made on-line and 45% through mail/ SGVIE mailbox (this does not include rent, recycling, etc.). There was some discussion regarding how to include the amount we earmark (accrue) for the R2 rep's attendance at the annual conference on the financial report. (We've not had this expense in recent years). Karen will review.
